OF

ARTICLE I - NAME

The name of this corporation is THE TANNERY CORP. (hereinafter, "Corporation").

ARTICLE II - PRINCIPAL PLACE OF BUSINESS ADDRESS


ARTICLE X-SHAREHOLDERS MEETING REQUIRED

ARTICLE XI-AMENDMENT


