The undersigned, for the purpose of forming a corporation under Florida Statutes §621, Professional Service Corporation, does hereby adopt the following Articles of Incorporation:

ARTICLE I - NAME

The name of the Corporation is: Edgar L. Jarvis, P.A.

ARTICLE II - DURATION

The duration of the Corporation is perpetual.

ARTICLE III - PURPOSE

The general purposes for which the Corporation is organized are the following:

A. To engage in and transact a real estate brokerage business, as well as any lawful business for which corporations may be incorporated under Florida Statutes §621. No other purpose limits this general purpose in any way.

B. To do such other things as are incidental to the purposes of the Corporation or necessary or desirable in order to accomplish them.

ARTICLE IV - CAPITAL STOCK

The aggregate number of shares which the Corporation is authorized to issue is 10,000 shares of common stock. Such shares shall be of a single class and shall have a par value of \$0.01 per share and shall be designated as voting or non-voting.

ARTICLE V - INITIAL REGISTERED OFFICE AND AGENT

ARTICLE VIII - INCORPORATOR

ARTICLE IX - AMENDMENT

The Corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation or any amendment to them, and any right conferred upon the Shareholders is subject to this reservation.


ARTICLE X - COMMENCEMENT OF CORPORATE EXISTENCE

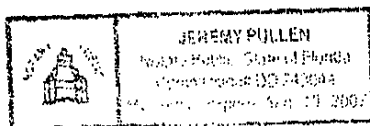
