



ARTICLE I. NAME

The name of this corporation is
CELL PHONE REPAIR CENTER OF PALM BAY, INC.

ARTICLE II. DURATION

This corporation shall have perpetual existence.

ARTICLE III. PURPOSE

ARTICLE IV. CAPITAL STOCK
