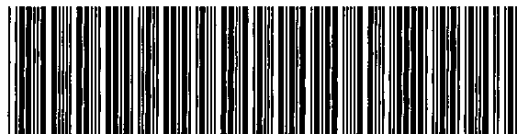

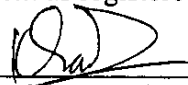

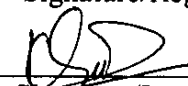
ARTICLE X AMENDMENT
