ARTICLES OF INCORPORATION OF ZA 2007, INC.

SECRETARY OF STATE

The undersigned incorporators, being competent to FLORIDA contract, subscribe to these Articles of Incorporation to form a corporation for profit under the laws of the State of Florida.

ARTICLE I - NAME

The name of this corporation shall be ZA 2007, INC. The principal address of this corporation is 4931 Chase Oaks Drive, Sarasota, FL 34241.

ARTICLE II - BUSINESS AND ACTIVITIES

The board of directors may authorize and require the payment of reasonable expenses incurred by directors attending meetings of the board of directors.
- D. Nothing in this article shall be construed to preclude the directors from serving this corporation in any other capacity and receiving compensation therefrom.
