The undersigned, for the purposes of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE I-NAME

The name of the corporation is: Zeepzap, Inc.

The term of existence of the corporation is perpetual.

forming the corporation.


