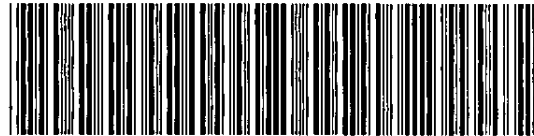

SHARES


