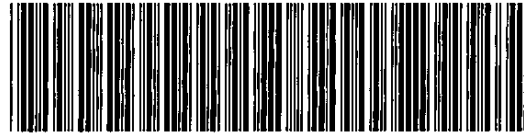

ARTICLE I - NAME

The name of the corporation is **AMERICAN WATERJET & FABRICATING SERVICES, INC.**

ARTICLE II - DURATION

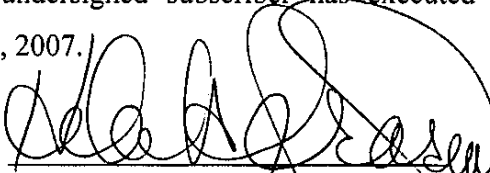
ARTICLE VIII - BY-LAWS

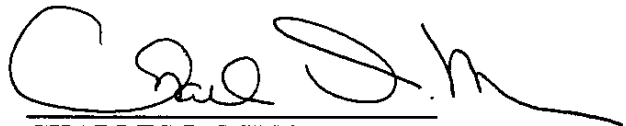
