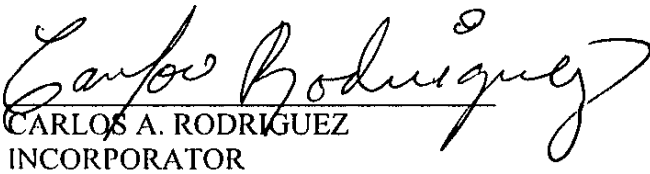
ARTICLE VIII – INDEMNIFICATION

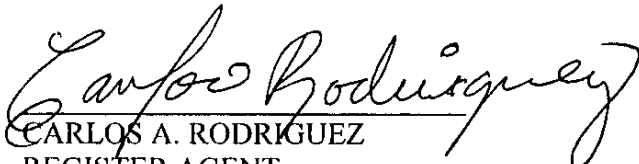
