ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF BANRURAL EXPRESS, INC.

Pursuant to the provisions of Sections 607,1003 and 607,1006 of the Florida Statutes, the undersigned corporation hereby adopts the following Articles of Amendment to its Articles of Incorporation:

1. The name of the corporation is:

BANRURAL EXPRESS, INC.

2. The Articles of Incorporation are amended by deleting Article VI in its entirety and substituting therefor the following:

"ARTICLE VI, BOARD OF DIRECTORS

The corporation shall have one (1) director initially. The number of directors may be increased from time to time, as provided in the By-Laws, but shall never be less than one. The name and street address of the director is:

The qualification, time and manner of election or appointment, the duties, terms of office, and manner of removing officers shall be as set forth in the corporation's By-Laws.
