#### ARTICLES OF INCORPORATION

OF

### DANA APPAREL OF WESTON, INC.

The undersigned, acting as incorporator of DANA APPAREL OF WESTON, INC. under the Florida Business Corporation Act, adopts the following Articles of Incorporation.

### ARTICLE I. NAME
