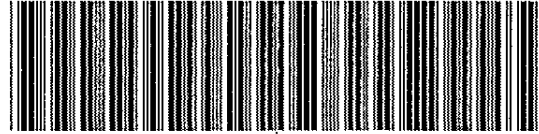



NAME
