ARTICLES OF INCORPORATION

OF

THE UNDERSIGNED, acting as sole incorporator under Chapter 607 of the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation for JOURNEYS COUNSELING CENTER, INC., a Florida corporation (the "Corporation"):

ARTICLE I
NAME
