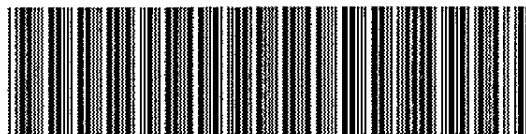

OF

ARTICLE ONE

The name of this corporation is ESTERO-NAPLES REALTY, INC. and the mailing address of the corporation shall be 13724 Collina Court, Estero, Florida 33928.

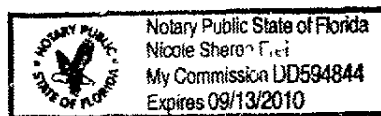

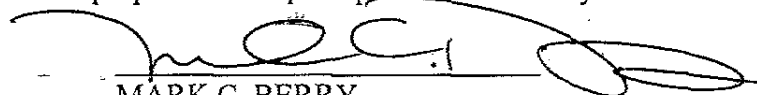
