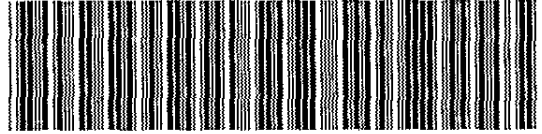



ARTICLE I - NAME

The name of this Corporation is Adelheid C. Reinoso, M.D., P.A.; the mailing address is 3700 Washington Street, Suite 202, Hollywood, Florida 33021.


ARTICLE IX

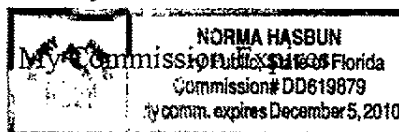
