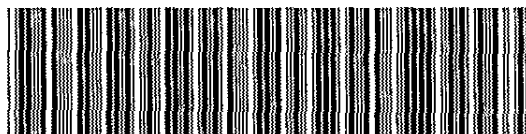



The name of the corporation is CHASOLEN SEMINARS, INC.

All shareholders are entitled to cumulate their votes for directors.


#### ARTICLE 10. - INDEMNIFICATION

ARTICLE 11. - AMENDMENT



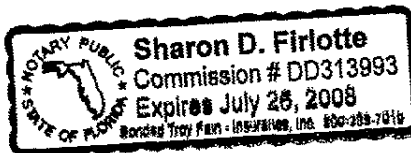
