ARTICLE III - PURPOSE

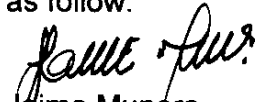
This corporation is organized for engaging in any activities or business permitted under the laws of the United States and the State of Florida.

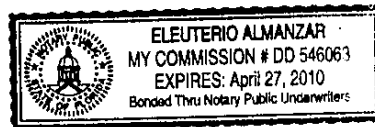
