The undersigned, acting as incorporator of this Corporation pursuant to Chapter 607 of the Florida Statutes, hereby forms a corporation for profit under the laws of the State of Florida and adopts the following Articles of Incorporation for such Corporation:

ARTICLE I - NAME OF CORPORATION

The name of this Corporation shall be I F T Commercial Sales, Inc.

ARTICLE II - PRINCIPAL OFFICE AND MAILING ADDRESS

The principal office of this Corporation shall be located at 650 Douglas Avenue, Suite 1040, Altamonte Springs, Florida 32714, which shall also be the mailing address of the Corporation.

ARTICLE III - CAPITAL STOCK

This Corporation shall indemnify any officer or director, or any former officer or director, to the full extent permitted by law.


ARTICLE VIII - DATE OF EXISTENCE
