I, the undersigned, in order to form a corporation AMASSER PRORIDA pursuant to the provisions of the Law of Florida for the purposes set forth below, hereby subscribed to these Articles of Incorporation.

#### Article I

The name of the corporation shall be ATHENA MEDICAL SPA AND WELLNESS CENTER, INC.

#### Article II

The purposes and general nature of the business to be conducted and transacted by the corporation shall be as follows:
