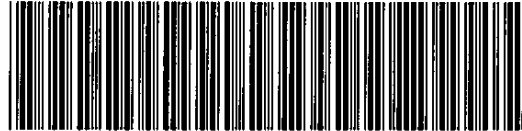

ARTICLE I: NAME

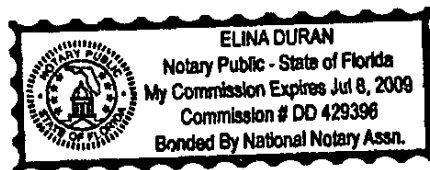
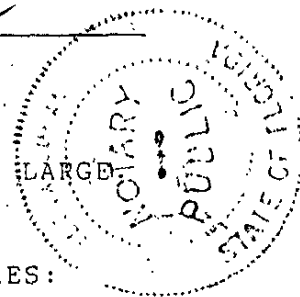
