The Articles of Incorporation of SUNBURST DEVELOPMENT COMPANY 2, INC., approved and filed in the office of the Secretary of State, State of Florida, on September 4, 2007, under documents #P07000098593 are amended as follows:

1. The Third Article of said Articles of Incorporation is deleted and shall be replaced with the following:

"THIRD: The primary purpose of the Corporation shall be the owning, operating, managing and leasing of real property as a hotel, or otherwise, and activities incidental thereto. The foregoing notwithstanding, the Corporation may also engage any and all lawful activities permitted under the laws of the State of Florida."

2. The Fourth Article of said Articles of Incorporation is deleted and shall be replaced with the following:

"FOURTH: The total number of shares, which the Corporation shall have the ability to issue is one thousand (1,000) shares of commons stock, par value \$1.00 per share."

3. The first sentence of subparagraph 1. of the Ninth Article of said Articles of Incorporation is deleted and shall be replaced with the following:

"1. A majority vote of the Board of Directors is required to take or cause the Corporation to take any of the following actions:"

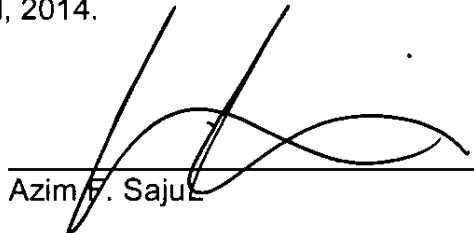
4. Subparagraphs 2. and 4. of the Ninth Article are hereby deleted in their entirety.
