The undersigned subscribers to these Articles of Incorporation, is (are) natural person(s) competent to contract, hereby forms a corporation under the laws of the State of Florida.

ARTICLE I - NAME

The name of this Corporation is: SIETE DIAS, CORP.

ARTICLE II - PRINCIPAL PLACE OF BUSINESS

ARTICLE III - NATURE OF BUSINESS

The general nature of the business to be transacted by this Corporation is newspaper publishing and any lawful business or trade permitted under the laws of the United States and of the State of Florida.

ARTICLE VI - INITIAL REGISTERED OFFICE AND AGENT


