FOR SUB S CORPORATION FOR

The undersigned, for the purposes of engaging and organizing a corporation under the laws of the State of Florida, do hereby associate themselves and adopt the following Articles of Incorporation for such corporation:

I. **NAME:** The name of the corporation shall be SeeVision Technologies, Inc., and it is to be located at 10085 Hernando Ridge Road, Weeki Wachee, Hernando County, Florida 34613.

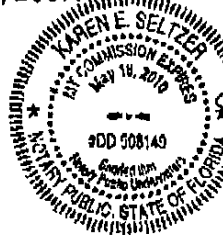
