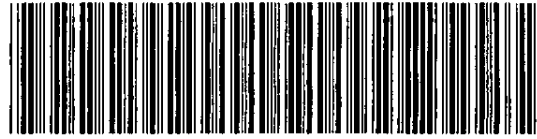

**ARTICLES OF INCORPORATION**

The undersigned subscriber to these Articles of Incorporation, desiring to form a Corporation under the laws of the State of Florida, does hereby accept all of the rights and privileges, benefits and obligations conferred and imposed by said laws and does hereby adopt the following Articles of Incorporation as the Charter of the Corporation hereby organized.

**ARTICLE I**

**NAME AND ADDRESS**

The name and address of the corporation is **Association for Diver Development, Inc.,**  
**9764 - 150<sup>th</sup> Ct. N., Jupiter, Florida 33478.**

**ARTICLE II**

**DURATION**

This corporation shall have perpetual existence commencing with the filing of these Articles of Incorporation, unless terminated earlier.

**ARTICLE III**

**PURPOSES AND POWERS**

This corporation is organized for the purpose of engaging in all lawful businesses permitted to a corporation under the Florida General Corporation Law, as in effect from time to time.

**ARTICLE IV****CAPITAL STOCK**

The amount of capital stock authorized shall consist of the Hundred Shares (100) of common voting stock having a par value of fifty cents (\$.50) each.

Dividends to shareholders may, in the discretion of the Board of Directors, be paid in cash or in property but no dividend may be made which would impair the restricted or reserved unearned surplus of the corporation, except as provided by Florida law.

**ARTICLE V****INITIAL REGISTERED OFFICE AND AGENT**

As Registered Agent, Eleanor L. Yarnick hereby acknowledges that she is familiar with and accepts the duties and responsibilities as Registered Agent of the Association for Diver Development, Inc.

**ARTICLE VI****INITIAL BOARD OF DIRECTORS**
