**ARTICLES OF INCORPORATION
OF
ONIQUE INVESTMENTS, INC.**

In compliance with the requirements of F.S. Chapter 607, the undersigned hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the Corporation is: ONIQUE INVESTMENTS, INC.

ARTICLE II

The street address of the principal office of the Corporation is: 9948 Little River Dr., Miami, FL 33147.

ARTICLE III

The maximum number of shares this Corporation is authorized to issue is 750, par value \$1.00 per share, all of which shall be Common Shares. All Common Shares shall be identical with each other in every respect and the holders of Common Shares shall be entitled to one vote for each share on all matters on which shareholders have the right to vote.

ARTICLE IV

The initial street address of the Corporation's registered office is: 9948 Little River Dr., Miami, Florida, 33147. The initial registered agent for the Corporation at that address is: Veronique Rolle-Vigille.

ARTICLE V

ARTICLE VI

Every shareholder, upon the sale for cash of any new stock of this corporation, shall have the right to purchase his pro-rata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

This election has the legal effect of granting the shareholders a preemptive right on uniform terms and conditions prescribed by the Board, to acquire proportional amounts of UNIQUE INVESTMENTS, INC., unissued shares after the Board decides to issue new shares. This provision is to protect shareholders from dilution of their proportionate interest, control and value of UNIQUE INVESTMENTS, INC., stock.

A shareholder may waive his preemptive right upon written notice to the Board and such waiver is irrevocable.
