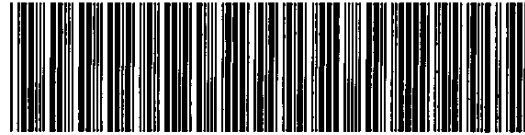

ARTICLES OF INCORPORATION

OF

K A J SERVICES, INC

In Compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the Corporation ("Corporation") shall be K A J Services, Inc.

ARTICLE II

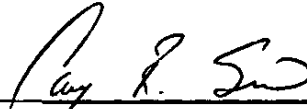

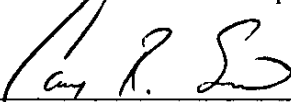
