The undersigned, acting as incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation:

**ARTICLE I  
CORPORATE NAME**

The name of the corporation shall be Destro Services, Inc., and the corporation's principal address shall be 1821 N.E. 65th Street Ft. Lauderdale, FL 33308.

**ARTICLE II  
TERM OF EXISTENCE**

This corporation shall have perpetual existence commencing upon the filing of these Articles of Incorporation.

**ARTICLE III  
NATURE OF BUSINESS AND POWERS**

The purposes for which the corporation is organized are to engage in the business of provision of construction related activities, and the general nature of the business to be transacted by this corporation is to engage in any and all business permitted under the laws of the United States of America and the State of Florida.

**ARTICLE IV  
CAPITAL STOCK**

The corporation shall have the authority to issue 1,000 shares, all of one class of capital stock, with a par value of \$0.01 per share.

**ARTICLE V

BOARD OF DIRECTORS AND INITIAL DIRECTORS**

AMENDMENT**


**ARTICLE IX

The preemptive right of any holder is determined by the ratio of the authorized shares of common stock held by the holder to all shares of common stock currently authorized.


