# ARTICLES OF INCORPORATION OF JOPAR, INC.

The undersigned, acting as Incorporator of a Florida corporation under the Florida HASSEE, FLORIDA Business Corporation Act, Chapter 607 of the Florida Statutes, hereby causes to be delivered the following Articles of Incorporation:

#### ARTICLE I NAME

The name of the corporation shall be JOPAR, Inc. (hereinafter, the "Corporation").
