# ADDENDUM TO ARTICLES OF INCORPORATION OF GSO IC-DISC, INC.

## ARTICLE III PURPOSE

The purpose of the corporation is to buy, sell and deal in personal property, real property and services and any other activities for which corporations may be organized under Chapter 607 and 621 Florida Statutes.

## ARTICLE IV SHARES

The aggregate number of shares which the corporation shall have authority to issue is 1,000,000 shares at \$.10 par value each. The shares shall be designated as Common Stock and shall have identical rights and privileges in every respect.

## ARTICLE VII EFFECTIVE DATE
