ARTICLES OF INCORPORATION

The undersigned hereby makes, subscribes, acknowledges, and files this certificate for the purpose of becoming a Professional Service Corporation pursuant to Chapters 607 and 621 of the Florida Statutes:

ARTICLE I

Name

The name of this Professional Service Corporation (the "Corporation") shall be ORAL AND FACIAL SURGERY CENTER OF TALLAHASSEE, P.A.

ARTICLE II

Purpose

This Corporation shall be organized for the purposes of engaging in the practice of maxillofacial dentistry and any ancillary business as are allowed a professional service corporation under Florida Law.




