Pursuant to the provisions of Section 607.1006, Florida Statutes, this Florida Profit Corporation adopts the following Amendments to its Articles of Incorporation:

- A. Article I of the Articles of Incorporation is amended to provide that the name of the corporation is: Commercial Pain Management, P.A.
- B. Article III of the Articles of Incorporation is amended to provide that the purpose for which this corporation is organized is:
