ARTICLES OF INCORPORATION OF TAMPA BAY TESTING CENTER, INC. A FLORIDA CORPORATION

The undersigned, for the purposes of forming a corporation under the Florida General Corporation Act do hereby adopt the following Articles of Incorporation:

ARTICLE I

NAME

The name of the corporation is: TAMPA BAY TESTING CENTER, INC.

ARTICLE II

DURATION

The term of the existence of the corporation is perpetual.

ARTICLE III

PURPOSE

The general purposes for which the corporation is organized:

- To engage in the business of testing individuals for certification in various professions or trades.
- 2.
