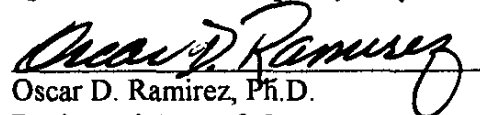

**ARTICLE I
NAME**

The name of the Corporation shall be: **Blessings From the Garden Inc.** hereafter, referred to as the "*Ministry.*" For convenience, these Articles of Incorporation shall be referred to as the "Articles" and the Bylaws of the Corporation shall be referred to as the "Bylaws."

**ARTICLE II
ADDRESS**

The initial address of the principal office, and the mailing address of the Ministry shall be: 13090 N.W. 107th. Avenue, Hialeah Gardens FL. 33018.

**ARTICLE III
PURPOSE OF THE MINISTRY**

This is a for profit corporation pursuant to Chapter 607 or 621, Florida Statutes. This Ministry shall engage in a wide variety of activities designed to produce income that may be distributed to any number of other ministries, organizations, non profit organizations or entities.

This Ministry is empowered to do and perform any and all such matters and things as are allowed by law and may be reasonable, convenient, or necessary to attain the objectives and ends for which it is organized as herein established.

**ARTICLE IV
CORPORATE STOCK**

The number of shares of stock that this Ministry is authorized to have initially shall be 10,000 shares of stock.

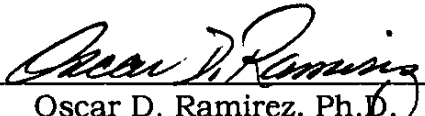
