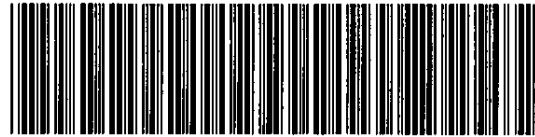

The street address of the initial registered office of the corporation is 2736 E. Highway 316, Citra, FL 32113.






