WE, THE UNDERSIGNED, hereby associate ourselves together for the purpose of becoming a corporation under the laws of the state of Florida providing for the formation, liability, rights, privileges and immunities of corporatious for profit.

ARTICLES L NAME

The name of this corporation shall be:
