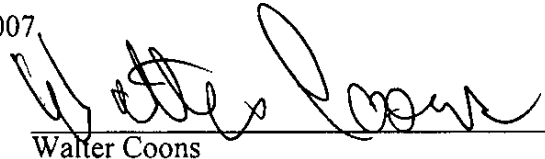
#### **ARTICLE VIII - AMENDMENT**
