The undersigned, hereby makes, subscribes, acknowledges and files the set Articles of E. F.L.0 of Incorporation for the purpose of becoming a corporation under the laws of the State of Florida.

#### ARTICLE I

#### **NAME**

The name of this corporation is RANDI CORPORATION The principal business address is 2962 Alton Road, Miami Beach, Florida 33140.

#### ARTICLE II

#### **DURATION**

This corporation shall have perpetual existence which shall commence at the date of the filing of these Articles with the Secretary of State.

#### ARTICLE III

#### <u>PURPOSES</u>

The corporation may engage in any activity or business permitted under the laws of the United States and of the State of Florida.

#### ARTICLE IV

#### **AUTHORIZED SHARES**

The capital stock of this Corporation shall consist of one hundred (100) Shares of Common Stock of one U.S. Dollar and no cents (\$1.00) par value each, all or part of said stock to be issued from time to time as may be determined by the Board of Directors. There shall be no preemptive right granted to the stockholders with respect to the shares of the corporation. - 1. condition precedent to holding an office in the corporation.


- 3. Except as otherwise provided by law, the Directors may prescribe a method or methods for replacement of lost certificates, and may prescribe reasonable conditions by way of security upon the issuance of new certificates therefor.

- 5.
