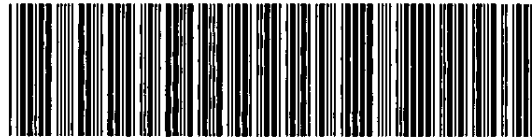

The undersigned does hereby submit these Articles of Incorporation for the purpose of forming a business corporation for profit under Chapter 607 of the Florida Statutes:

1. **NAME.** The name of the corporation is Professional Maintenance USA – Florida, Inc.
2. **PRINCIPAL OFFICE.** The corporation's principal office shall be located at 389 Clearwater Drive, Ponte Verde Beach, Florida 32082. The corporation's mailing address shall be One Crosley Field Place, Cincinnati, Ohio 45214.
3. **PURPOSE.** The purpose for which the corporation is organized is to engage in any lawful business for which nonprofessional corporations may be organized in the State of Florida.

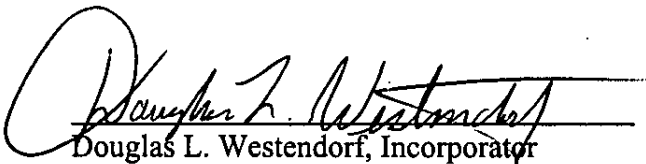
