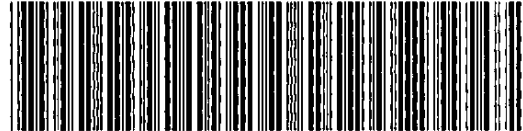

ARTICLES OF INCORPORATION
OF
BELLE FEMME, BEAUX GENS, INC.

ARTICLE I.

NAME

The name of this corporation is Belle Femme, Beaux Gens, Inc.

ARTICLE II.

PRINCIPAL OFFICE

The principal office and mailing address of this corporation is 1901 Dr. Martin Luther King, Jr. Street North, Suite B, St. Petersburg, Florida 33704.

ARTICLE III.

DURATION; EFFECTIVE DATE

This corporation shall exist perpetually, commencing as of September 12, 2007.

ARTICLE IV.

PURPOSES

This corporation may engage in any activity or business permitted under the laws of the United States of America and of this State.

ARTICLE V.

CAPITAL STOCK

This corporation is authorized to issue Ten Thousand (10,000) shares of One Dollar (\$1.00) par value common stock.

ARTICLE VI.

REGISTERED OFFICE AND REGISTERED AGENT

The name of the initial Registered Agent of this corporation and the street address of the initial Registered Office are Joel D. The Registered Agent, by his execution of these Articles of Incorporation as incorporator, accepts the appointment as registered agent and agrees to comply with the provisions of all statutes relative thereto, including the obligations of § 607.0501, Florida Statutes.

ARTICLE VII.

INITIAL BOARD OF DIRECTORS

This corporation shall have one (1) director initially. The number of directors may be either increased or decreased from time to time as provided in the Bylaws, but shall never be less than one (1). The name and address of the initial director of this corporation are Deborah V. Epstein, 1901 Dr. Martin Luther King, Jr. Street North, Suite B, St. Petersburg, Florida 33704.

ARTICLE VIII.

INCORPORATOR

ARTICLE IX.

AMENDMENT


