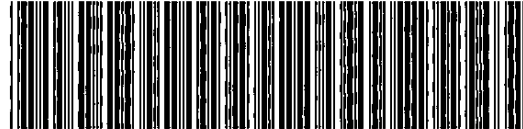

ARTICLE I - NAME AND PRINCIPAL ADDRESS

The name of the corporation is CATHODIC PROTECTION, INC., and the principal address and principal place of business is 5430 70<sup>TH</sup> AVENUE NORTH, PINELLAS PARK, FLORIDA 33781.

ARTICLE II - REGISTERED OFFICE AND AGENT
