The name of this corporation is Digex North America Corp.

AUTHORIZED SHARES

The aggregate number of shares which the corporation shall have authority to issue shall be Twenty Five Thousand (25,000) shares of voting common stock with \$1.00 par value per share.

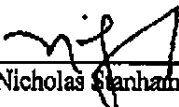
ARTICLE X

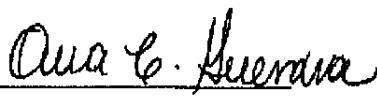

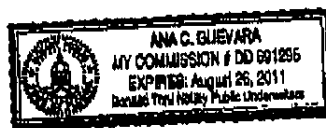

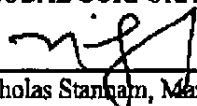
