ARTICLE I Name and Address of Corporation

The name of this corporation shall be LATIN AMERICAN REINSURANCE INTERMEDIARY SERVICES, INC. The principal place of business and address is 1401 Sawgrass Corporate Parkway, Suite 131, Sunrise, Florida, 33323.

ARTICLE II Duration
