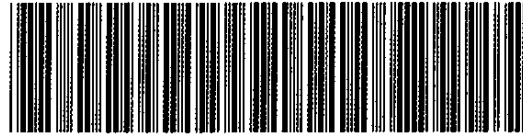

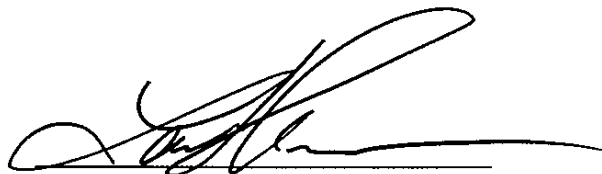

**ARTICLES OF INCORPORATION

The undersigned subscriber to these Articles of Incorporation, natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

**ARTICLE I
Name**

The name of this corporation is: **Coastal Building Solutions, Inc.**

**ARTICLE II
Duration**

The corporation shall commence its existence as of the 14th day of September 2007 and shall continue to exist perpetually until such time of legal dissolution.

**ARTICLE III
Corporation Purpose**

This corporation is organized to transact any or all lawful business for which the corporation may be incorporated pursuant to Chapter 607, Florida Statutes, or any applicable laws of the State of Florida.

**ARTICLE IV

ARTICLE V

Capital Stock

This corporation is authorized to issue One Thousand (1,000) shares of One Dollar (\$1.00) par value common stock.

ARTICLE VI

Preemptive Rights

Every shareholder, upon the sale for cash of any new stock of this corporation of the same kind, class or series as that which he already holds, shall have the right to purchase his pro-rata share thereof as nearly as may be done without issuance of fractional shares at the same price at which it is offered to others.

ARTICLE VII

Stockholder and Corporation Option to Purchase Stock

In case a shareholder desires to sell his shares of stock, he must first offer the shares for sale to the remaining stockholders, it being the intention to give them a preference in the purchase of such shares, and any attempted sale in violation of the provision is null and void.

If none of the shareholders desire to purchase the shares of stock, the stockholder must then offer the corporation the options to purchase, it being the intention to give the corporation the second preference in the purchase of such shares, and any attempted sale in violation of this provision is null and void.

A stockholder desiring to sell his stock shall file notice in writing of his intention with the secretary of the corporation, stating the terms of the sale, and unless his terms are accepted by any or all of the other stockholders within ten (10) days, then the corporation has five (5) days to exercise its option. If neither the shareholders nor the corporation exercises their option, then they shall be deemed to have waived their privilege of purchasing, and the stockholder will be at the liberty to sell to anyone else according to the terms specified above.

ARTICLE VIII

Initial Registered Office and Agent

ARTICLE IX
Initial Board of Directors

This corporation shall have one director initially. The number of directors may be either increased or diminished from time to time by the By-Laws.

ARTICLE X

This corporation reserves the right to amend or repeal any provisions contained in the Articles of Incorporation, or any amendment hereto, and any right conferred upon the shareholders is subject to this reservation.

ARTICLE XIV
Indemnification

The corporation shall indemnify any officer or director, or any former officer or director, to the full extent permitted by law.

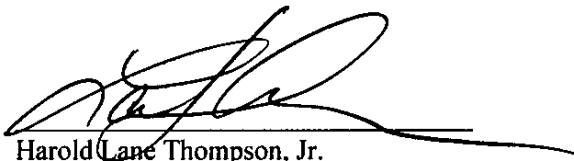
ARTICLE XV
Informal Action of Directors

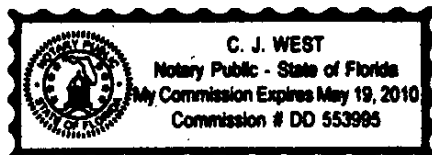

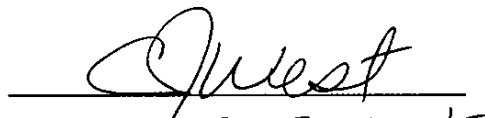

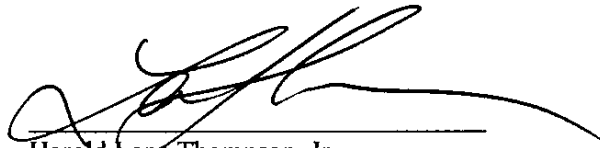
