ARTICLE I - NAME OF CORPORATION

The name of the corporation is **JERAE ENTERPRISES, INC.**

**ARTICLE II - NATURE OF BUSINESS
LAUNDRY SERVICES**

The corporation is authorized to conduct any lawful business in the State of Florida which is not prohibited by law, rule or regulation.

The initial address of the principal office of the corporation is to be at 6705 Arno Way, Boynton Beach, Florida 33437.


The Board of Directors may from time to time designate such other address and place for the principal office of this corporation as it may see fit.
