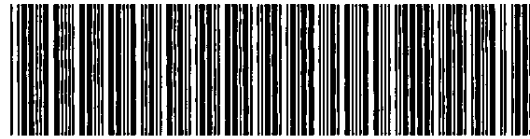



prescribed by Florida General Corporation Act:


