**ARTICLES OF INCORPORATION
OF
BEGAL ENTERPRISES OF SOUTH FLORIDA, INC.**

ARTICLE I.

The name of this Corporation shall be: Begal Enterprises of South Florida, Inc.

ARTICLE II

The principal office and mailing address of the Corporation shall be at the address set forth below. However, the Board of Directors may from time-to-time in its discretion change the location of the principal office as it deems appropriate.

ARTICLE III.

The Corporation may engage in any activity or business permitted under the laws of the United States and under the laws of the State of Florida.

ARTICLE IV

The Corporation is authorized to issue a maximum of five thousand (5,000) Shares of Stock. The Shares of Stock shall be voting common stock having a par value of One Dollar (\$1.00) per share.
