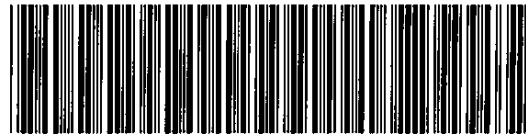

The undersigned subscribes to these Articles of Incorporation, natural persons competent to contract, form this corporation under the Laws of the state of Florida.

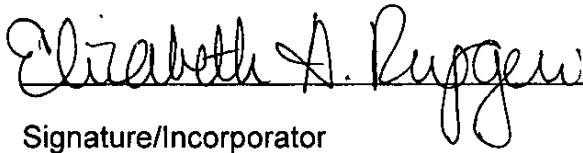
