ARTICLES OF INCORPORATION OF

SEGRETARY OF STATE TALLAHASSEE, FLORIDA

The undersigned, who, if a natural person, is eighteen years of age or older, hereby establishes a corporation pursuant to the Florida Business Corporation Act, as amended, and adopts the following Articles of Incorporation:

Article I. Corporate Name

The name of this corporation is Coast Atlantic Property Management, Inc.

Article II. Duration

The corporation shall have an effective of October 1, 2007, upon the filing of these Articles with the Florida Department of State, and shall exist perpetually.

Article III. Purpose

The corporation is organized for the purpose of transacting any or all lawful business permitted under the laws of the State of Florida and of the United States.
