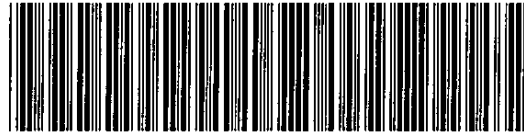

**ARTICLES OF INCORPORATION  
OF**

I the undersigned, being of full age, do hereby, for the purpose of forming and organizing a corporation for profit under the provisions of the Corporation Laws of the State of Florida, adopt and declare the following Articles of Incorporation covering the existence and organization of the corporation.

**ARTICLE I – NAME**

The name of this corporation shall be:

**ARTICLE II – ADDRESS**

Each of the said shares of stock shall entitle the holder thereof to One (1) vote at any meeting of the stockholders. All or any part of said capital stock may be paid for in cash, in property, or in labor or services at a fair valuation to be fixed by the Board of Directors at a meeting called for such purposes. All stock when issued shall be paid for and shall be non-assessable. The corporation is authorized to issue only one class of stock, and all issued stock shall be held of record by not more than thirty (30) persons. Stock shall be issued and transferable only to natural persons who are not nonresident aliens.

The shares of capital stock of this corporation shall be issued initially to:

If the laws of Florida are amended after the filing of these Articles of Incorporation of which this Article is a part to authorize corporate action further eliminating or limiting the personal liability

of directors, the liability of a director of the Corporation shall be eliminated or limited to the fullest extent permitted by Florida law as so amended. Any repeal or modification of the foregoing paragraph by the shareholders of the Corporation shall not adversely affect any right or protection of a director of the Corporation existing at the time of such repeal or modification.

The existence of this corporation shall begin upon the filing with the Secretary of State's office, and thereafter the existence of this corporation shall be perpetual.




