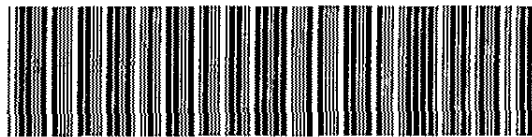

The undersigned, acting as incorporators for this business corporation pursuant to Chapter 607 of the Florida Statutes, hereby form a Business Corporation under the laws of the State of Florida and adopt the following Articles of Incorporation for such corporation.

ARTICLE I

NAME OF CORPORATION

The name of the corporation shall be BRITISH TEAROOM, INC.

ARTICLE II

TERM OF EXISTENCE

This corporation shall begin its corporate existence as of the September 19, 2007, and shall exist perpetually.

ARTICLE III

GENERAL PURPOSE

The general purpose for which this corporation is organized shall be the sale of beer, wines, food, china and related products of service and all things in connection therewith that are related under the laws of the State of Florida. The business of the corporation shall be limited to the foregoing activities

ARTICLE IV

CAPITAL STOCK

The maximum number of shares of capital stock that this corporation is authorized to issue and have outstanding at any time is One Thousand (1,000) shares of common stock, having a par value of One Dollar (\$1.00) per share.

ARTICLE V

DIRECTORS AND INCORPORATORS

The initial number of Directors of this corporation shall be one (1). The number of Directors may be increased or diminished from time to time with Bylaws adopted by the shareholders but shall never be less than one (1).

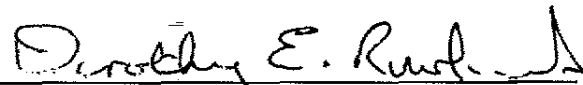
ARTICLE VII

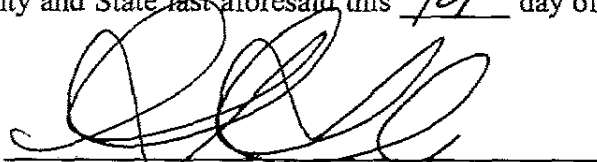

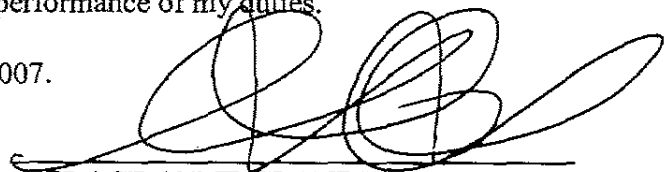

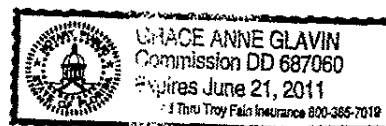
